



Bringing the DATA EQUALITY Findings to the Field

Between June and July 2026, the Court of Appeals of Venice and Agenfor International organised and delivered **three Cascade Trainings** across Italy, engaging 298 participants in total (public officials, legal professionals, judicial practitioners and law enforcement) around the intersection of AI, data governance and fundamental rights.

1. European Digital Regulatory Framework

29 June 2026 | Online & Bologna | 106 participants

Organised in collaboration with ANCI, this opening session unpacked the EU's regulatory landscape for digital technologies such as the AI Act, GDPR, the Digital Services Act and copyright law with particular attention to the responsibilities that come with using AI in contexts touching fundamental rights and police prevention.

2. Bias in AI Systems

30 June 2026 | Online & Venice | 97 participants

The second session turned to justice practitioners, examining how AI-supported decision-making can introduce bias and discrimination. Drawing on the project's own findings, discussions covered procedural safeguards and data governance, reinforcing how EU legislation can steer a rights-based, responsible use of AI in judicial and public settings.





3. Data Discrimination and European Judicial Cooperation

14 July 2026 | Online & Rome | 95 participants

The final training tackled one of DATA EQUALITY's central findings: *How fragmented or incomplete data undermines European judicial cooperation.*

Participants explored the practical impact on **Framework Decisions 2008/909/JHA, 2008/947/JHA and 2009/829/JHA** and what that means for access to justice and mutual recognition.

The session also unveiled the results of the Italian National Exercise, presented operational recommendations, and closed with a live demonstration of the Agenfor digital platform and AI tools.

Three trainings, one throughline: equipping practitioners across Italy with the knowledge to navigate AI and data governance responsibly and to put the project's findings into practice.
